President made general comments on the following:

Welcome to this year's AGM and thank you all for your attendance.

I will mention the highlights of our association activities for 2017

This year has been another successful year for the association and that means we have maintained the reason for existing;

The purpose of the Association is to promote and reinforce the spirit, reputation, image and competencies of the Corps through its past, present and future members.

The goals of the Association are to:

- 1. Promote the Corps' identity and reputation in South Australia
- 2. Recognise and celebrate achievements of members of the Corps in South Australia
- 3. Provide a focal point for Corps activities in South Australia

We held our normal functions such as the ANZAC event, participated in the march on ANZAC Day, held the all ranks dinner and today obviously the AGM followed by the Birthday function.

In addition, we also supported the function in recognition of WO2 Doug Pammenter (RTD).

2017 has been a key year for our Corps in general as we celebrate the 75th Anniversary of the formation of RAEME.

I was particularly pleased to have secured nearly \$2500 in grant funding toward a suitable event celebrating this anniversary. This money was used to subsidise costs of all those who attended the All Ranks Dinner held at the Naval Military Club in Sept. I regard to this event we have decided that all future event s of tis nature will not be restricted to serving members only. This is as a result of the 2 previous years initial attendance being below expectations and last-minute change to invite partners.

I see not change to the event calendar for next year but would welcome ideas for any new functions, particularly those type of events that may encourage new members to attend.

Another activity this year was the handing over of executive responsibility for the RNA to Victoria. While this has been largely completed it was not as straightforward as envisaged. Since the handover there has been a restructure of the RNA proposed which has been widely supported and the RNN will soon be ratified and commence to exist.

Once again, we raised significant funds through the Bunnings BBQs and this maintains the strong financial position of the association (more in the treasurer report).

I want to acknowledge the efforts of all the committee members.

Don, Tony, Greg, Bob, Bob, Mike and Marg, John, Brian, Geoff, and Judy all play significant parts in sustaining the association.

Also, particular acknowledgement to Colonel Cocker for his oversight as Colonel Commandant SA/WA/NT. Colonel Cocker attends all meetings and has been also attended all association functions and some unit functions not only in Adelaide but also in WA.

I do see the committee as being the only risk to the association, as we look back over previous years the same names appear as the members of the committee. I realise this is common in small associations however we do need to somehow create some interest from younger members who may bring fresh ideas and suggestions that ensure the ongoing success of the association.

In closing I thank you again and look forward to the next 12 months being equally as successful.
